

GENERAL BENEFITS OF MSUO

- Identification of similar maritime issues
- Development of joint working and problem solving
- Close information gaps in individual projects
- Provision of Maritime Safety professional contacts
- Integration of maritime safety with spatial planning of coastal and marine areas
- A co-ordinated voice to speak at the European and International level
- Development of future funding opportunities
- Guide future funding programmes



SUMMARY

- Share experience and outcomes to ensure a safer marine environment with no duplication of effort
- Use MSUO to ensure Eligibility, Compatibility and Responsibility
- Develop new projects for the future (2007-2013)
- Link Proposed Projects to Risk
 Assessment/Prevention (Maritime Safety, habitat sensitivity) and Management of Water & Coastal Areas (marine policy) under new Programme



PLACE IN MSUO

The BALANCE contribution to the MSUO are:

- To provide common standards for Baltic marine data.
- To provide a metadatabase for maritime institutions in the Baltic Sea Region with public access.
- To provide broad scale marine landscape maps based on physical parameters (bathymetry, currents, geology etc.) for the Baltic Sea.
- To provide detailed habitat maps for 4 pilot areas based on physical and biological data.
- To provide examples of inshore and off shore zone planning based on natural, cultural and socio-economic information.



PLACE IN MSUO

The BALANCE interests in the MSUO are:

- To gain knowledge of relevant projects and institutions in the Baltic Sea and North Sea Region.
- To use the joint publicity and dissemination facilities (if necessary and cost effective).
- To gain support for use of co-funding for cross regional co-operation with other INTERREG projects e.g. the NWE MESH project.
- To win the planned tender for habitat sensitivity (joint effort with MESH?)
- To provide input to and help to prepare new initiatives for the future programme period (2007-2013) for the Baltic Sea & North Sea Regions.



Specific Project to Project Co-ordination could be:

- Development of a provisional European System for habitat sensitivity mapping using the European Environment Agency´ EUNIS classification (cross regional).
- Prioritise natural and cultural values together in a common agreed system for use when planning e.g. emergency harbours and emergency response etc.
- To test the above systems in connection with Maritime Assistance Service (oil & shipping accidents) in a future project....



BENEFITS

Benefits to BALANCE and the partnership:

- Easier to approach MSUO project partners for socioeconomic data.
- Cross-regional expenses will be made eligible.
- Development of a provisional European system for habitat sensitivity mapping opened for tender for INTERREG IIIB project partners.
- Seminars on habitat mapping, modelling, blue corridors.
- Dissemination facilities (Gateway web site, Newsletters etc.)
- BALANCE will have influence on the future Programme Period 2007-2013
- The BALANCE partnership will be in a key position for shaping a future partnership.



COSTS

Costs for participating:

- App. €50 000 for the BALANCE participation.
- Has to be paid up front to the MSUO & new extra funding.
- Is eligible funding which will be reimbursed.
- Staff time, OH etc. is eligible, but the MSUO still have to be hired as a consultant.
- National authorities & research institutions should have an interest in shaping the future programme.
- Should BALANCE decided the application needs updating before the 23rd of September 2005.
- BSR INTERREG IIIB needs answer within a week.
